## SUBJECT: Call for proposal for communication services in the field of projects

Innova BIC Srl, in the context of projects in progress, should develop communication activities. In particular, the 4 projects and specifications of the supply are indicated in the technical annex (1). All the Annexes (Annex 1, Annex 2 and Annex 3), which are an integral part of this letter of invitation, must be downloaded from the website: www.innovabic.it

With this letter, addressed to advertisement companies and professionals based in Europe, you are invited to offer the supply of services as indicated in the technical annexes.

The offer, duly signed by the legal representative, must contain:

- A report demonstrating the history of the company in the implementation of similar activities, with details of clients, activities and amounts of services provided; The report must also contain a specification of at least 3 similar projects carried out and the opportunity to see the output of these projects (website, folder, etc.).
- A description of the technical characteristics and quality of the services that you want to provide, as well as the implementation methods to be adopted;
- The declaration referred to in Annex 2;
- An indication of the overall economic offer and of the unit prices offered for the realization of the services requested for each project, filling out, signing and sending the Annex 3 (Economic Offer);
- This letter of invitation and the technical Annex 1 signed by the Legal Representative for acceptance.

The offer, in a closed envelope, sealed and signed on the closing flaps, with the words "OFFER FOR COMMUNICATION SERVICES WITHIN PROJECTS", must be received at the office of Innova BIC Srl, Via G. La Farina n. 17, 98122 Messina, not later than 12.00 am on 12/10/2015. Offers arriving after the deadline indicated above will be excluded.

The choice of the offer will be made through the following parameters:

- Quality (in terms of products and services offered): 40 points
- Experience in similar projects and activities: 40 points
- Price: 15 points
- Additional services: 5 points

At the most advantageous price for Innova BIC Srl will be assigned a score of 15 points, to the other prices inversely proportional scores. For the allocation of the other parameters taken into account, the score will be awarded by a Commission within the limits of the value as expressed above. The choice will be made in favor of the Company that has achieved the highest overall score, expressed in cents.
